Easley Christian School seeks to provide onsite educational services or supports to meet the differences of exceptional needs students by offering the following services:

Testing Accommodations - provided to students with a diagnosis that warrants those accommodations. If the amount of time or the testing location are not conducive to the student being able to succeed, additional time and/or an alternative location are made available.

Remedial instruction is offered for students with a diagnosed learning difference that affects their math, reading, and/or writing. Students in grades 7-12 are given remedial instruction in a Learning Resource Class during a non-core subject hour. The Learning Resource teacher is able to work toward the closing of learning gaps and the accomplishing of individualized goals with intentionally chosen curricula and manipulatives. For students in the lower school, remedial instruction is currently provided within the classroom setting as time allows.

Counseling referrals are provided to students and families upon request.

Easley Christian School seeks to provide these services to students diagnosed with ADD, ADHD, mild cases on the Autism spectrum, and students with other learning disorders.
