
Why are the report cards different from the past?

State Law

- Schools, not districts, receive overall ratings
- Overall rating based on 100-point scale
- Each indicator also receives a rating
- Ratings must be: Excellent, Good, Average, Below Average and Unsatisfactory
- Online report cards
- Other data required by law or proviso to be reported i.e. NAEP results


Federal Law

- Academic Achievement must only include ELA and math
 - English language proficiency required
 - Graduation Rate required
 - Academic Progress left to state discretion
 - Must have indicator for School Quality/Student Success
 - Must report subgroup performance on all indicators

ESSA School Accountability: **Required Indicators**

ESSA requires states to use a set of indicators to measure the performance of all schools. The academic progress, progress towards English language proficiency, and school quality/student success indicators are all new under ESSA.



ALL ACCOUNTABILITY MEASURES MUST:

- Be applicable to all schools
- Allow for meaningful differentiation of schools
- Be disaggregated by student group (i.e., ethnicity, lunch status, gender, disability, etc.)
- Be valid and reliable across all schools







Career Readiness Assessment

The Career Readiness Assessment (Ready to Work (R2W) formerly WorkKeys) is a job skills assessment system measuring "real world" skills that employers believe are critical in the workplace. The results below are displayed only for students who received a high school diploma during the current report card year.

In order to receive the National Career Readiness Certificate, a measure that indicates a student has the foundational workplaceskills to succeed, a student must take three subtests in Applied Mathematics, Reading for Information, and Locating Information.

Students can earn certificates at the Platinum, Gold, Silver, and Bronze level on the Career Readiness Assessments. A designation can only be earned after a student has taken the three subtests required for the National Career Readiness Certificate.




