Full Committee Meeting

Minutes of the Meeting
June 12, 2023

Mr. Robinson, filling in for April Allen, called the meeting to order. As the first order of business, members moved to approve the minutes from the prior full committee meeting on April 17, 2023. The minutes were approved as they stood. Next, Mr. Robinson welcomed Mike King for a review of the South Carolina Adult Education program.

Mr. King provided a review of the structure of the Adult Education program in South Carolina as compared to other states. In South Carolina, there are currently 51 adult education providers, with over 150 sites and adult education providers available in all 46 counties. Mr. King then provided a demographic breakdown from 2018 to March 1, 2023. Ms. Barton noted that those in the 17-21 age bracket tend to do far better than those 22 and over. Mr. King noted that the younger students in adult education programs tend to perform better as they are not as far removed from school as their older counterparts. Mr. King highlighted the different program levels, noting that students at a lower level take a much longer time to complete the process. Sen. Loftis asked if reading poses the greatest challenge for students, with Mr. King stating that reading is key to the entire program. Mr. Ferguson asked if these numbers indicate completers, not all who attended an adult education program, which Mr. King confirmed. Dr. Booker asked if adult education enrollment is increasing now, after the pandemic, which Mr. King confirmed. Ms. Yow asked if these programs are free, with Mr. King noting that the majority are but that a small few have registration fees. Ms. Yow asked what other barriers exist aside from the cost of registration. Mr. King noted that transportation, family care, and childcare make up the most significant barriers to adult education enrollment and attendance.

Mr. King then described some items currently in development, such as creating a high school diploma plan for the Department of Corrections and establishing career pathways in partnership with CTE. Ms. Barton thanked Mr. King and noted that this data has been some of the most reliable from the program so far. Mr. Robinson thanked Mr. King and introduced Ms. Hairfield to provide the first subcommittee report of the meeting from Barbara Hairfield, chair of the Joint Academic Standards and Assessments and Public Awareness Subcommittee. Ms. Hairfield provided the committee with an overview of the action items: the report on the Educational Credit for Exceptional Needs Children (ECENC) Program, the report on the Educational Performance of Military-Connected Students in South Carolina, and a report outlining the US History and Constitution End-of-Course Evaluation. Ms. Hairfield then introduced Dr. Christine DiStefano to provide a follow-up on the US History EOC Evaluation and to answer any questions members might have.

Dr. DiStefano noted that the test performed well and that a majority of items met the criteria, but that two did not so it is recommended to review these items and follow up. Dr. DiStefano noted that items go through a rigorous review and that all new and old items have to meet benchmarks in order to be included. This review was conducted by way of alignment meetings. Out of 545 questions in the bank, 32% were discarded, while 373 were aligned. Ms. Hairfield noted that the motion to bring the report to committee must be seconded before questions, Neil Robinson seconded Ms. Hairfield's motion. Sen. Loftis asked if the changes made were due to a change in standards, with Mr. Ferguson noting that science provides a good example, as content is realigned between grade levels. Ms. Hairfield noted that for the US History EOC, the content is not changing, just the skills needed, bringing the evaluation to a higher standard of rigor. Mr. Robinson moved to approve this report. This motion was seconded, and with all in favor, the motion carried. All members voted in favor of the three reports.

Ms. Hairfield then introduced Dr. Matthew Lavery to provide members with information on revisions to accountability in modified in-year reporting. Dr. Couch then provided members with a review of two items from the EIA and Improvement Mechanisms Meeting held on May 15th, the Teacher Loan Program annual report and an update on Palmetto Gold and Silver. Dr. Couch moved the Teacher Loan Program annual report to the full committee, with all voting in approval.

Mr. Robinson introduced Mr. Ferguson for a review of the PASS Science Field Test and accountability waiver for grades four and six. Mr. Ferguson stated that this proposal will be submitted to the federal Department of Education for review. As standards are approved, a timeline will be submitted to the EOC and State Board of Education. Sen. Loftis noted that, particularly with science, the seven-year cycle may not allow us to keep up with advancements. With no further comments, Mr. Robinson called on Interim Executive Director Dana Yow for an update. Ms. Yow provided information on the upcoming EOC retreat to be held on August 6-7 in Mt. Pleasant at the SC Ports Authority. Superintendent Ellen Weaver and RFA Executive Director Frank Rainwater will present.

Mr. Robinson called an executive session to provide members with an update on the EOC Executive Director search. When members returned from executive session, Mr. Robinson noted that no action was taken and that the search committee unanimously submitted a nomination for Dana Yow to take the position of EOC Executive Director. Dr. Tate noted her support for the nomination, as did Mr. Robinson and Sen. Johnson. All members voted in favor of the appointment. With Ms. Yow appointed EOC Executive Director, the meeting adjourned.
