Call for Nominations: South Carolina Survey Advisory Group

Seeking nominations for stakeholder representatives to serve for one or two years starting July 2023

The South Carolina Education Oversight Committee (EOC) is seeking nominations from organizations and individuals representing relevant stakeholder groups to serve on its newly established Survey Advisory Group (SAG). Please see the <u>South Carolina EOC Survey Advisory Group</u> document (henceforth, the "SAG Document") for a detailed description of the Duties, Scope, and Membership of the SAG.

In brief, the SAG Advisors shall:

- Represent the perspectives and interests of their relevant stakeholder groups while providing input on survey-related projects conducted by the EOC (including but not limited to the Climate Surveys)
- Consult and advise on proposed modifications or revisions to surveys currently in use by the EOC,
 and to assist the EOC in setting priorities for future survey-related work
- Provide insight on summaries, analyses, and visualizations of survey results and provide input on the utility of the information the surveys provide for relevant stakeholders
- Identify areas for possible improvements or modifications of surveys to better suit their purposes and/or to provide more actionable data to relevant stakeholders
- Provide input and/or feedback on relevant policies, procedures, and support documents or materials related to surveys
- Advise on communications strategies with relevant stakeholders concerning surveys
- Provide input on the use of surveys in the School Accountability System.

Nominations for Advisors are now being accepted from groups and organizations which represent the stakeholders described in the SAG Document, as well as from individual members of one or more stakeholder groups listed in the SAG Document.

For both nominations and self-nominations alike, please submit the following information for *each* nominee:

- 1. The full name, phone number (mobile preferred), and email address of the nominee
- 2. The Group or Organization with which the nominee is affiliated (if applicable)
- 3. A *brief* paragraph (no more than 150 words) describing how individual being nominated would provide benefit to the work of the SAG
- 4. A list of which of the stakeholder groups mentioned in the SAG Document the nominee represents (note that we expect nominees will likely represent multiple groups; please list all that apply)

Appointed Advisors will be notified of their selection for service <u>no later than July 26, 2023</u>. The first SAG Meeting will be a virtual meeting and will take place in the afternoon of Wednesday, August 9, 2023.
